ORIGIN and PURPOSE of the CONCEPT

Brief Outline

To inspire the world to fresh economic dynamics and a further development of Intellectual Property, we need to foster the creative power (*not just inventive!*) of the small or medium size enterprises in all the levels that affect our personal activities. As much as in enterprises offering **services** (*unpatentable creations*) than in **technology-oriented enterprises** (*patentable creations*), which stand as the standard bearers of an unquenchable thirst for knowledge, they account for no less than **90%** of international innovations. This explains why they have the lion's share of the job market. They hold the power to enrich our future, if we open the gates to the possibility for them to do so.

Given that these creative, but modest-sized enterprises cannot fairly engage in a legal warfare against multinationals on matters related to international patents and court procedures, it is imperative that we offer them a tool that provides them with not only the ability to **facilitate their access to worldwide intellectual property**, but also **simplify ~ or even eliminate ~ the need to take legal action**.

- Sold at a fixed price, it instantaneously provides worldwide property

- Based on the **creation of a work** (*which occurs prior to invention*), it not only covers **service-oriented concepts**, but also industrial inventions.

- Its non-publication ensures that the author's **secrets**, which are intrinsic to his property, **remain undisclosed** for a long as necessary. Such non-disclosure also allows the author to improve his initial concept, even after creating his literary and artistic work. Such changes only incur minor additional fees. Unlike patent, it can be **modified as often as necessary**. Furthermore, this non-disclosure allows businessmen to patent the invention, without any conflict with the inventor.
- **An original business plan** is comprised in the package, **without supplement**.
- It also includes **a set of international contracts**, applicable to any business situation, **without supplement**.
- It confers the author the exclusive and true property, instead of providing a temporary monopolistic title, hence (*unlike the patent*) giving the burden of proof to the copier, rather than to the injured party. - **Patent agents and their lawyers** find an answer to three long-standing concerns:
 - 1 - The formal identification of an invention with its author;
 - 2 - The indubitable legitimacy of the author's initial claim of ownership on his creation;
 - 3 - The creator's ability to safeguard the secrecy of his property for as long as is necessary.

This explains why, unlike patent, the *Intellectual Passport CB* carries a **Legal Guarantee!**
